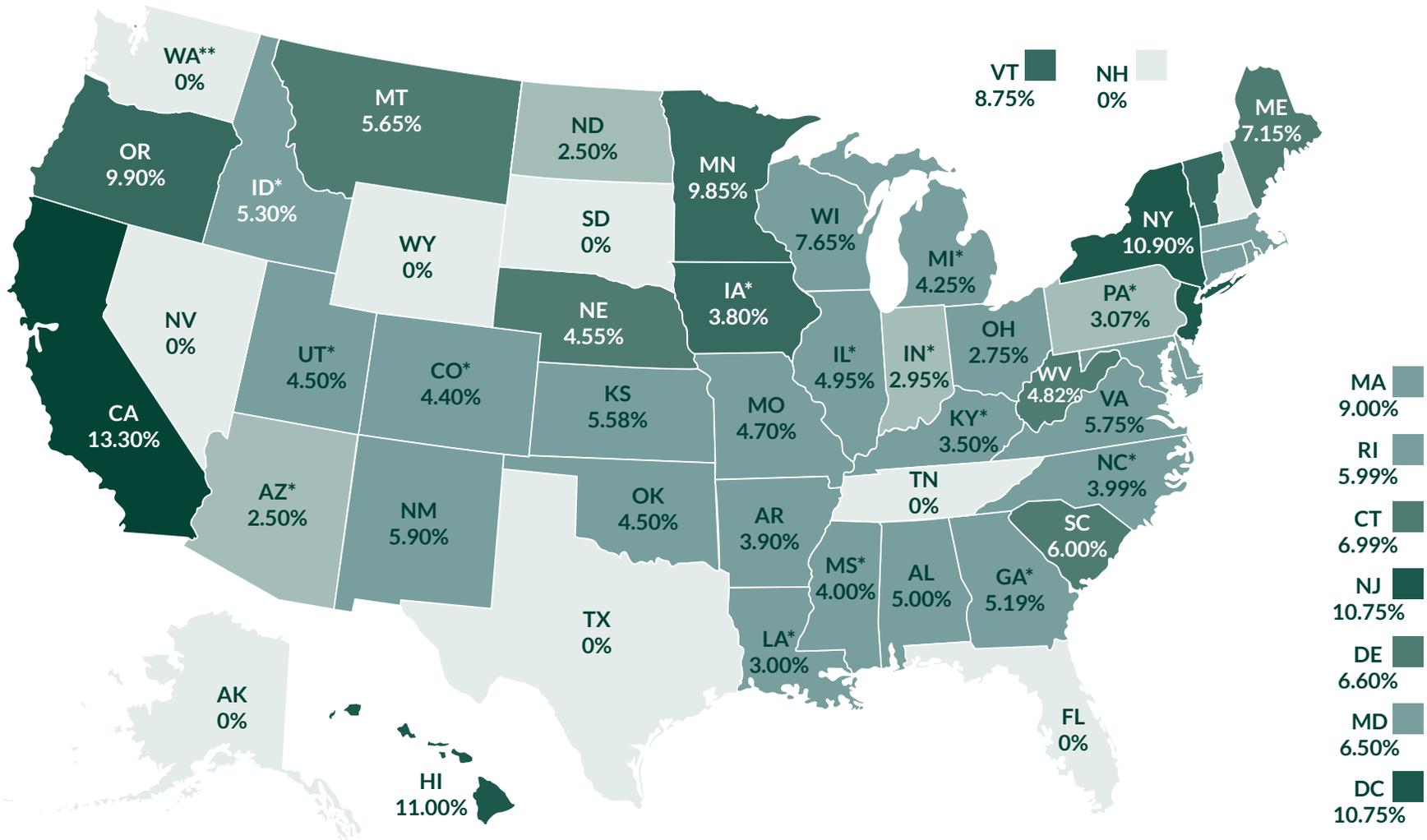


How High Are Your State Income Tax Rates?
