Refresher: What is a 1031 Exchange?

If your customers are selling an investment property such as rental condominium units, apartment buildings, office buildings or shopping centers, they may be interested in utilizing at a 1031 Exchange. A 1031 Exchange offers real estate investors one of the last great investment opportunities to build wealth and save taxes. By setting up a 1031 Exchange prior to closing/escrow, a seller will defer the capital gains taxes and depreciation recapture typically due when property is sold. They simply need to purchase a new investment property of equal or greater value.

Does the Role of the Title Company Change When Closing/Escrow Includes a 1031 Exchange?

IPX1031 works with the seller before closing to set up the 1031 Exchange and, for the most part, closing/escrow is the same as if there was not a 1031 Exchange. However, there are a few differences. For example, the wire for seller's proceeds will be sent to a segregated 1031 account established by IPX1031. IPX1031 will provide the wire instructions and work with you to ensure that all wire verification protocols are followed.

The regulations that govern 1031 Exchanges are very specific and must be followed by the customer in order to have a successful exchange. The Tax Code requires taxpayer to use a Qualified Intermediary, like IPX1031, to both facilitate and hold funds during an exchange.
